#### **1. Period of Validity:**

This Agreement shall be valid for a period of 3 year. This MOU shall be terminated upon mutual consent and discussion with a notification of 30 days.

#### **2. Use of names and trademarks**

Both the Parties agree that neither will use the name of the other Party or its employees or any trademark associated with the other Party in any advertisement, press release, or publicity with reference to this Memorandum or any product, trademark or service resulting from this Memorandum, without prior written approval of the other Party.

#### **3. Confidentiality**

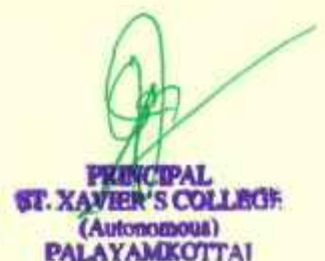
Neither party shall use any confidential information it receives from the other party otherwise than for the purposes of this MOU or for the purpose of fulfilling a statutory, legal obligation.


